1. Please enclose Bank draft for full amount, attested photocopy (2 Nos.) of your valid Arms License and attested copy of PAN card with the application.
2. Bank drafts should be drawn in favour of **“General Manager, M. T. P. F. Ambarnath”** payable at **SBI Ambarnath (Branch Code 001040)**.
3. Amount required for booking is **Rs. 78176/- (full amount)** for .32 Revolver
4. Please see **Terms & Conditions of Sale** and sign on **“Acceptance Note”** on page 2.

## TERMS AND CONDITION OF SALE

1. Application will be accepted only in prescribed form, which can be obtained from the factory or downloaded for internet website "[www.ofb.gov.in](http://www.ofb.gov.in)" and "[www.ofbindia.gov.in](http://www.ofbindia.gov.in)"
2. Only Indian Citizens having valid Arms License for NP bore revolver issued by appropriate Civil Authority are eligible to purchase IOF make weapons.
3. Filled applications are accepted by Registered Post / Speed Post. If any person wants to submit Application form directly in the factory, it will be accepted only between 3.00 to 4.00 PM on working days except Saturday and Sunday.
4. Incomplete forms/ illegible forms / forms without proper enclosures will be rejected and returned to the applicant. Factory will bear no responsibility whatsoever in such case.
5. An applicant can **PROVISIONALLY** book one revolver at a time. Orders will be booked on day-to-day basis in the sequence of receipt of applications in the factory. After receiving the Application Form & DD, the genuineness of the Arms License will be verified from the Licensing Authority. After obtaining the confirmation from Licensing Authority, the booking will be regularized. **In case, the License is not found genuine, the entire amount will be forfeited.**
6. **In case of cancellation of order on customer's request, Rs. 1000/- will be deducted as Cancellation charge.**
7. Incomplete Forms will summarily be rejected. Factory reserves the right to refuse to book any order without assigning any reason what so ever without giving any notice.
8. **Delivery of Arms:** Call letters for collection shall be issued to the individuals strictly as per the serial of registration of order, provided full payment is received beforehand in the factory. No OUT-OF-TURN allotment of weapon to the individuals will be done. Weapon will be delivered in the premises of the factory to the purchaser on production of Original Arms License and other documents as required as per the Arms Act 1959 and Arms Rules, 1962. Collection is allowed through retainer, if retainer's name is endorsed and his photograph pasted and attested by licensing authority on the license. The retainer must bring from the purchaser an authority letter for collecting the weapon, with his signature attested by the purchaser.
9. In case the applicant fails to complete the formalities for collection of weapon within 2 months after the last call-date, the order shall be cancelled and the amount deposited will be refunded after deducting Rs. 1000/- as cancellation charge. Factory reserves the right to extend or refuse to extend the above time limit without assigning any reason whatsoever.
10. **Price / Duties / Taxes applicable on the date of actual supply will be charged. Applicant has to deposit the balance amount required, even if he has deposited full amount as per the old rates before the date of revisions. Any increase in Taxes/Duties or new levies effective from or prior to the date of delivery but coming to the notice of the factory at a later date will also be payable by the customer within one month of demand.**
11. Every effort will be made to effect supplies as per the serial of booking, but no assurance is given to this effect. No liability will be accepted for any changes in the sequence of supply for any reason what so ever.
12. No claims or demand for any loss or damage due to delayed execution of order will be entertained.
13. No responsibility or liability will be accepted for Postal delays.
14. Right is reserved to cancel any order without assigning any reason and without giving any prior notice. In this event, payments received against such orders will be refunded as due.
15. No liability is accepted for compensation or interest on the payment received against the order booked with the factory for any reason what so ever.
16. The design features of the Revolver .32 may change without any prior notice.
17. Notwithstanding what have here-in-fore been stated, factory reserves the right to sell the weapon to any Govt. Department / Autonomous Body / PSU out of turn as per allotment orders from Ministry of Defense, Govt. of India.
18. **Warranty:** Factory shall repair the weapon for manufacturing defects free of cost at its premises, if the weapon is brought to factory's premises **within twelve months** of the date of purchase and if factory is satisfied that the defect is not one due to bad usage, neglect or mishandling. Factory can also repair weapons at its premises after the period of twelve months, if the purchaser pays the cost of repairs. Liability for consequential loss or damage is neither accepted nor implied. **Weapons once sold will not be taken back / exchanged for any reason whatsoever.** There are no service outlets other than MTPF, Ambarnath for revolver .32" sold by the factory.
19. **Arbitration Clause:** Except where otherwise provided in the Terms and Conditions for sale, all questions and disputes arising in connection with this contract shall be referred to the sole Arbitrator to be appointed by the Chairman, Ordnance Factory Board. It will be no objection that Arbitrator so appointed is a Govt. Servant. The award of the arbitrator shall be final and binding on the parties to this contract. The Arbitration & Conciliation Act 1996 and Rules made there under for time being in force shall be deemed to apply to the Arbitration proceedings under this clause.
20. **Weapons will not be saleable / transferable for five years from the date of purchase / supply.**
21. All disputes shall be subject to Ambarnath (Kalyan) jurisdiction only.
22. The above procedure of sale is subject to alteration or modification at any time without any notice at the discretion of the Chairman, Ordnance Factory Board.
